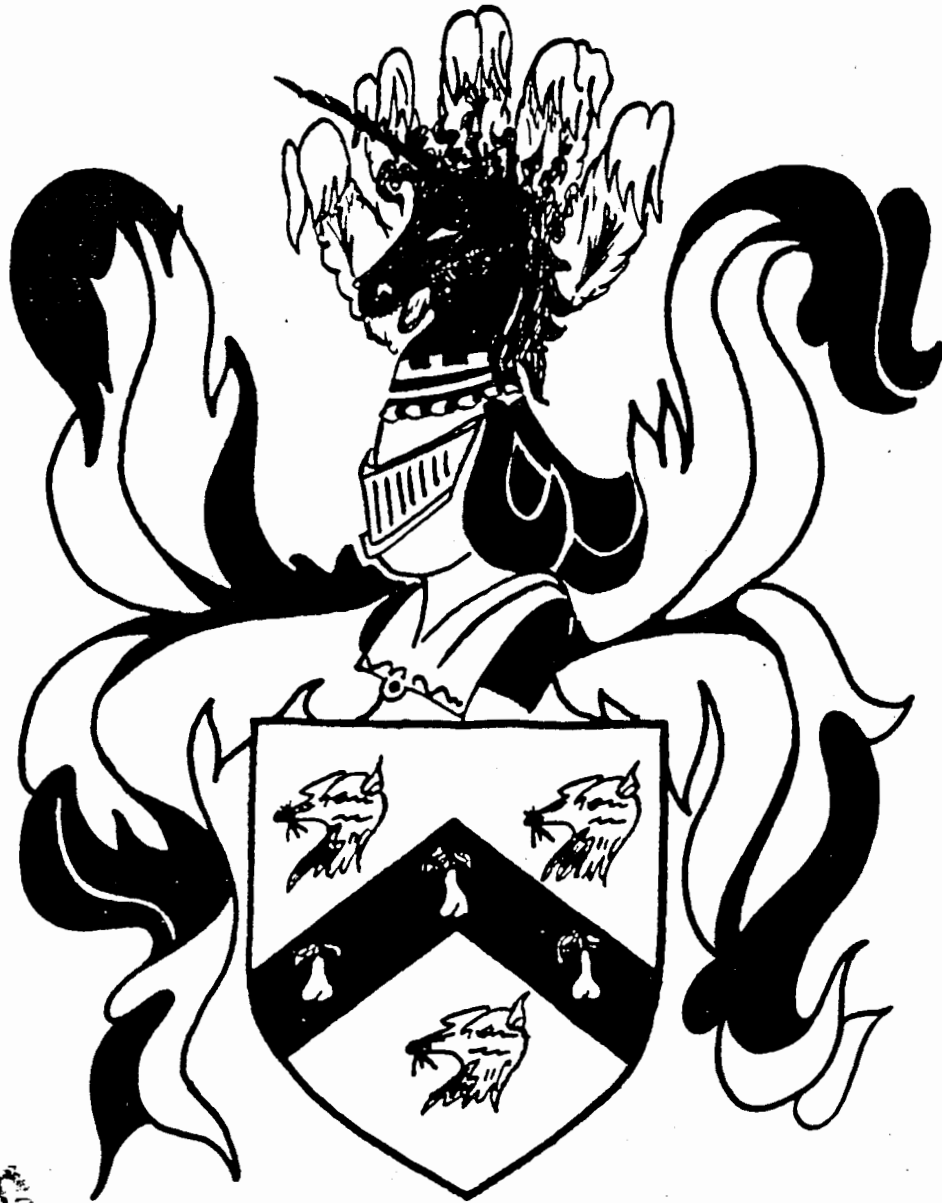

THE EDITOR'S DESK

This Mississippi and Tennessee issue completes Volume II of the Upshaw Family Journal. Our data files have continued to expand in spite of the great amount of data we have printed in these two years and I am grateful to everyone who has contributed or helped us in any way. The continuing persistence of many Upshaw researchers is a constant source of inspiration.

We will henceforth be known as The Upshaw Family Association of America, with it's official publication being "The Upshaw Family Journal". The Upshaw Family Association of America has been designated a non-profit organization by the Internal Revenue Service whose ruling, dated 27 Aug 1975, reads in part: "Donors may deduct contributions to you as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to you or for your use are deductible ...". Our stationery and magazine format will soon reflect this improvement in our organization.

In regard to this, I wish to ask any members who have ideas or suggestions for our magazine or organization to submit them and to express your opinions concerning the following specific changes which are presently under consideration.

The Upshur-Upshaw arms on the cover can be replaced with a different Upshaw photograph for each issue. The UFJ can be printed by offset, rather than by mimeograph, which would allow pages to be printed on both sides; reduction can be employed to place more printing on the same size (8½ x 11) page, although the characters would be slightly smaller in size. There are a number of other changes presently under consideration and although most of them would mean a general improvement in the quality and appearance of our publication, they will also add greatly to our printing costs, thereby reducing the funds we have available for research. In short, we must "pay the piper" and I want your opinions before instituting changes of this magnitude. How about it, members?

I have a rather large supply of loose sheets to back issues of the UFJ which is mostly complete, missing only a few pages. If any members wish any of these loose pages, please send a list of the pages desired with a self-addressed stamped envelope (or ample postage) to the Editor who will gladly send them.

Another regular column is initiated in this issue, "Notes and News", which will present current Upshaw events. I need your help and support with this column, so please send in all Upshaw-related news items, obituaries, marriage and birth notices which, after being printed in the UFJ, will be preserved in a scrapbook for eventual deposit with the Georgia Department of Archives and History.

My wife and I look forward to an October trip to the South Carolina State Archives in Columbia and from there to the Virginia State Library in Richmond. We anticipate a very enjoyable trip.

Upshaw succumbs at 77

E. L. (Latt) Upshaw, 77, died Thursday morning (12 June 1975) in a Temple hospital after a short illness. The funeral was at 10 a.m. Saturday in Christ Episcopal Church in Temple with the Rev. Joseph Di Paola officiating. Burial was in the North Belton Cemetery.

Mr. Upshaw had lived in Temple for the past several years. He was a rural mail carrier and Belton postmaster for many years, and was secretary to Cong. W. R. (Bob) Poage for several years. He was a member of Christ Episcopal Church in Temple.

Mr. Upshaw was born in Belton June 19, 1897, and lived most of his life in Belton. He was a graduate of Belton High School and attended Baylor University. He was married to Ruth Whaling Nov. 26, 1924 in Dallas. Mrs. Upshaw died in 1970.

He is survived by a daughter, Mrs. Eugene P. (Gail) Costello of Dallas; two sons, Dr. Bill Upshaw of Temple and David L. Upshaw of Old Greenwich, Conn., and 13 grandchildren.

Homer Causey, retired Journal-Constitution printer, earned membership in my Edison Record Club by lending me disks from his collection for transfer to my tape library. After I returned Homer's records, I found one cassette was defective. I needed four Causey platters back.

Curtis Upshaw, of the ANI ad staff, was a neighbor of the Causeys. I asked him if he could bring me the records. He could and did.

A week ago yesterday I brought the records back to the office and to show Curtis my appreciation I carried along the tape player that he might hear the recorded results.

We met for coffee in the ANI vendeteria, along with Adman David Joiner, as we have almost every week since my retirement. I played the tape and we revelled in nostalgia - "Sleepy Time Gal" and "Three O'Clock in the Morning," jazz renditions.

Break over, we went our separate ways with a customary, "Have a good week."

Late Saturday afternoon Jacques "Jack" Upshaw called to tell me his brother Curtis had had a heart attack while working in the yard. He had died on the way to the hospital.

I have lost a valued friend, a lunch companion once a week for 10 years before my retirement.

Curtis Upshaw was a thorough, competent fellow, respected by his colleagues. His only job since 1937 had been with the newspapers, first The Constitution, then the combined operation.

Quiet, reserved, not much taller than I, a trim 135 pounds, he was not one's image of a bomber pilot, but that's what Uncle Sam trained him to be in WW II. He became a captain, a rank the modest Curtis never mentioned. "Jack" Upshaw told me that Saturday.

Curtis Upshaw was devoted to his wife Frances, to his home, his friends and his job. My one-day work week won't be the same without coffee with Curtis.

Mr. Charles B. Upshaw, Jr., sent the following article from the sports section of the Atlanta Journal-Constitution, dated 3 Mar 1975:

A Pitch For Tennis, Golf
Upshaw Learns In Off-Season
(By Charlie Roberts)

"I believe I've learned something from my golf swing this off-season that will make me a better baseball pitcher this coming summer," said Cecil Lee Upshaw, Jr., stretching his 6-6 frame and unleashing an imaginary submarine pitch.

"I'm glad to discover golf is good for something as much time as he spends playing it," countered Jeanne Louise Upshaw. "But it was really that tennis we played all winter that taught him you have to get out in front hitting a tennis ball or throwing a baseball right."

That was Cecil Lee Upshaw, Jr., the Braves-spawned submarine relief pitcher who has been surfacing with different American League clubs more often in the last year than he'd like - the one who hopes the Chicago White Sox will keep him long enough to find out what he can do for them next summer after he tries to show them in the in-progress spring training at Sarasota, Fla.

The same Upshaw, it was, whose baseball career and ... right index finger hung by a thread after he shot an imaginary basketball goal for cousin George Stone's edification in 1970 on a San Diego Street. The one-time Centenary College star went up and didn't come down. He hung by his ring from a metal awning in front of a parking lot, 200 pounds of him suspended by that skinny ring finger.

It was the dunk shot heard round the baseball world. A small, two-engined charter plane and a pilot he'd never seen roared through the early dawn over California for four hours to get him to Stanford Medical Center. And 62 days in a hospital, 15 hours in surgery, numerous operations later and Cecil resumed his baseball career, vowing everlasting retirement from basketball.

Now, some frustrating years at Atlanta, Houston, Cleveland and New York behind him, two other sports - golf and/or tennis - seemingly are playing a role in his baseball career too.

"It was really both tennis and golf," said the 32-year-oldster who in 1968 and 1969 posted 14-11 credentials and recorded some 36 saves coming out of the Atlanta bullpen to be ranked among the finest rescue workers in the land.

"I believe I've discovered a flaw in my delivery, and it's going to give me more velocity and also make my breaking pitch move up and away the way it should," Upshaw continued.

"Throwing from down under the way I do, it involves the same movement as hitting a golf ball or tennis ball. The impact for tennis or golf balls is comparable to the release when throwing a baseball from down under. I was not staying behind the ball. On a sidearm or underhand throw the right arm needs to stay under as in hitting a golf or tennis ball. It's hard to describe in print."

It had been a case of being so close to the forest he couldn't see the trees, a super-perceptive baseball wife thought. "Sometimes it takes something like that to make you see something you've been too close to realize," Jeanne Louise volunteered.

"Really, last season statistically - 0-1 at Cleveland and 1-5 with the Yankees was the worst I've ever had," said Upshaw. But there were redeeming features. "Actually, I was proud of the way I threw the ball last year. Four of my losses came on unearned runs, my earned-run average stayed under 3.00 until right at the end when Baltimore ripped me for five runs in two outings - and I gave up only two home runs all year in 68 innings - one by Milwaukee's Don Money while at Cleveland and one by Baltimore's Elrod Hendricks while at New York."

Upshaw, an eight-year big league veteran next June, enjoyed pitching at all his big league stops. But the Shreveport native - who once served as interim general manager of the Braves-owned Texas League team in his home town - figures Atlanta (or Decatur) is the best place to live. "Just because the Braves traded me doesn't mean they can run me out of town," he said.

"I believe I'll like playing for the White Sox. Whitlow Wyatt (former Braves' pitching coach) put some good words on Chuck Tanner (Chisox manager). The Sox gave me a little bit more than a cost of living raise - and these days that's a pretty good raise. Around 11 per cent."

Upshaw, who shoots golf in the 70s at Little Mountain Country Club "down on highway 155 in Henry County," took tennis lessons at East Lake Tennis Club this summer. And both sports, he figures, will contribute to a strong comeback in baseball for the fellow who started none of his 319 big league games.

LETTERS TO THE EDITOR

Dear Ted;

Allen J. Upshaw lived in what was first Natchitoches Parish, La., which was then cut off into Winn Parish in 1852. The land is located in the present corner of Natchitoches, Winn, and Grant Parishes, on a stream known as Upshaw Creek, near St. Maurice, La. Peter Upshaw (d 1841) and Allen J. Upshaw (d 1884) are probably buried on or very near this property.

Mary J. Upshaw, the apparent widow of Allen J. Upshaw and the daughter of Peter Upshaw, is shown in the 1880 census of Bienville Parish, La., where she had probably moved from the St. Maurice land to live with some of her children.

Concerning Forrester Upshaw's brothers, Richard and Drury: I am quite sure that relationship is correct. My father, Leroy Columbus Upshaw, always spoke of them when mentioning his grandparents, Forrester and Ann Upshaw; he said they called Drury "Dru" for short. This, to my knowledge, was not Drury Christian Upshaw, thought to be a descendant of Drury Christian and Elizabeth (Hunt) Upshaw of Amherst County, Virginia.

I do recall hearing some conversation concerning Forrester Upshaw, who had a son who had moved to Mississippi or Louisiana, and why Forrester wanted to go way down there when he was not well. The old fellow had gotten sick; I do not know if he died there or not - nor when, nor where.

Dear Mr. Brooke;

I have read with interest your listing of the Upshaw Family Journal in the May, 1975, issue of The Genealogical Helper. I am not a subscriber to the Journal, but I am directing this query to you with the hope that you may be in a position to assist me with a genealogical problem.

I am researching the BUFFINGTON family with the hope that in one particular line I will find an ancestor who served in the War of the American Revolution. This must be a direct blood line as I wish to submit the record which will satisfy the requirements for membership into the Daughters of the American Revolution.

In researching the Buffingtons I find they inter-married with the STARR families. One of these direct ancestors was Caleb Starr who was born ca 1758 and was in sympathy with England and was not with Revolutionary forces. He was buried near Evansville, Arkansas, which I interpret to mean he was not buried in the confines of the Cherokee Nation. By strange coincidence, one of the grandfathers of the paternal line, ELI TIPTON MATTOX, was also buried near Evansville, Arkansas, just across the line from the Cherokee Nation in Oklahoma.

Caleb's son was Ezekiel Starr, Sr. (1/4 Cherokee Indian); he married MARY UPSHAW, a white woman born in Georgia, ca 1819 in Tennessee. It occurs to me that Mary Upshaw's father was probably contemporary with Caleb Starr and of the right age to serve in the Revolution. This is mere speculation on my part; however, I hope to find her parents and/or grandparents.

I have the following data about the Starr - Upshaw, Starr - Buffington connection, which I would appreciate having any further information about:

CALEB STARR - an Irishman
 b ca 1758 in Chester County, Penn.
 d 1843, buried near Evanston, Arkansas
 m 1794 to Nancy (Nannie) Harlan. She was $\frac{1}{2}$ Cherokee Indian,
 b ca 1764 in Tenn, d 1841 and is buried near Evanston, Ark.

Their son was:
 EZEKIAL STARR, SR. - $\frac{1}{4}$ Cherokee Indian

- b 1802 on Conasayga Creek, McMinn County, Tenn.
- d 2 May 1846 in Washington, D.C., buried in Congressional Cemetery, Washington, D.C.
- m ca 1819 in Tennessee to Mary Upshaw, who was born in Ga. They were the parents of 11 children.

Their third child was Elizabeth Starr, born in 1827 in Tennessee; She married Ellis Buffington, Jr.

I wonder where Mary (Upshaw) Starr was buried. Since her husband, Ezekiel Starr, Sr., was buried in Washington (died 2 May 1846) she was not buried with him. I have a reference that the 8th child was born in Tennessee ca 1837. There were three children born after that but I have no record of where they were born. According to your information, "their family probably left Tennessee about the time of the Indian removal in 1838". He (Ezekiel) would not appear in the 1850 McMinn County census because he died in 1846. So the question is: Was Mary (Upshaw) Starr still alive? If not, where was she buried? If she was still alive in 1850, she may be listed in some census which might give some additional information.

Thank you for any courtesy you may extend and please be assured that I shall be grateful.

Early Giles County Marriages, by Mr. Andy Weddington, Rt. 3, Pulaski, Tenn; printed in Ansearchin' News, 1958-1959.

This list of early Giles County marriages is incomplete. Mr. Weddington has been accumulating the names over a period of three years, using the old Giles County newspapers as the source. The original records have been lost or destroyed and the present Courthouse records do not start until 1865.

This list of Giles County marriages seems to extend to circa 1864; the marriages are alphabetically indexed by groom; bride's names were searched name-by-name by Ted O. Brooke. No Upshaws.

Marriages of Giles County, Tennessee, 1818 - 1862; by Jean Waldrop Smith, 1952. Forword: Giles County, Tennessee, was established in 1810, and between that time and 1865 the County Court House was destroyed twice by fire. In the course of these fires the books in the County Court Clerk's office were destroyed to a great extent, including all of the marriage books. However, a few of the original marriage bonds and licenses were saved, and are stored in a room on the third floor, together with a number of other papers, making them inaccessible to the general public. These marriage licenses and bonds begin in 1818 and continue to 1865.

This book is fully indexed by groom, bride, bondsman, and etc. No Upshaw references found in index.

The next entry certifies that James W. Upshaw, Maria Hawkins, Lewis G. Upshaw, Harriett Cockrell, Elizabeth Harwood, Martha F. Edwards, Sarah Massie, Mason T. Upshaw, and Arthur M. M. Upshaw, heirs of James Upshaw, late of Essex County, Virginia, to whom the Military Warrant No. 3276 was issued by the state of Virginia, died intestate. All these heirs join in giving power of attorney to Arthur M. M. Upshaw.

The Pulaski Citizen, 17 Jan 1962; newspaper article contributed by Mrs. Grace E. Jared, who notes that Pulaski is the County seat of Giles County, Tennessee. Mrs. Jared feels that the below-mentioned John Upshaw may be identical, or related somehow, to the John Upshaw enumerated in the 1860 Webster County, Union Township, Missouri census. Mrs. Jared is certain this John Upshaw is not the brother of her grandfather, Dr. Geo. W. Upshaw.

Reading the Pulaski Citizen dated August 5, 1880:

What do you modern nimrods think of this for a hunting story? James Scruggs relates the following with good unction: In the year 1825, his father in company with Lewis Upshaw, Thomas Howard, John Upshaw and others went deer hunting in the region of country around Aspen Hill, at a place called Sugar Tree Ford. John Upshaw was placed on the stand, and in a very short space of time the drivers sent up several beautiful specimens of the game, all in a bunch. Mr. Upshaw took deliberate aim and fired at the whole lot. When the smoke cleared away he discovered that he killed five and wounded the remaining two. This remarkable feat is well authenticated by James Scruggs, who was a boy at the time. The gun which rendered such good service on the occasion is now in the possession of William Scruggs and is used by his little son in hunting squirrels.
