

#### Olin Eugene Upshaw

"Rosebud Money" would buy anything in the building at Upshaw's Store at Rosebud, Ga., for approximately half a century - 1908 until 1958.

That was all but 38 years in the life of 88-year-old Olin Eugene Upshaw, who still lives in Gwinnett County with his wife of more than 69 years.

They have a lot of memories about Rosebud Money, which was originated by him and his father.

"During hard times (depression years), a lot of people lived on that money," recalled Upshaw, a man prominent in his community, county and area of the state for more years than most people live.

That has been from his mid teens, when he went into business with his father.

"The store was established in 1894 by my father, P. C. Upshaw. Rosebud's own money didn't start until about 1908. (O. E. Upshaw was between 16 and 17 at the time).

Upshaw's wife, the former Mabel Davis, whom he married in 1911, built up the largest millinery business in this part of the country. according to her husband. Mrs. Upshaw, now 87, is ill with arthritis. "We'll be married 70 years next Jan. 25," said Upshaw.

Another first for the Rosebud store was sending out direct mail advertisements by postal card. "Every two weeks, we had 1,000 printed and mailed out to customers," recalled Upshaw.

His younger sister, Frances Upshaw Barrett, 72, visiting here with the Upshaws' daughter, Eugenia, from Nashville, Tenn. where they both reside, commented: "It was so crowded in the store, you couldn't see across it, after those cards would go out."

"Barbados served as a recruiting ground of settlers for other colonies in the Carribean and on the continent. From 1650 to 1680 nearly 30,000 whites left the island to establish in the colonies of Antigua, Montserrat, Virginia, New York, Rhode Island, Massachusetts, Jamaica, Surinam, and Carolina. This was the largest population movement during the 17th century. It included all classes, the large planter, the small planter, the 'yeoman farmer', the landless freeman, the indentured servant, and the Negro slave."

The main sources include Town Depositions (Pro Class C.24), High Court of Admiralty Libels and Dispositions (Pro Class HCA 13, 24, and 30), Exchequer Port Books (Pro Class E.190), PCC and locally proved wills, extracts from

over 400 Parish registers, Virginia County records (mainly York County), Virginia Colonial records project surveys, notarial records of Rotterdam and Amsterdam, Bristol lists of indentured servants for the Colonies, and a large collection of miscellaneous MSS relating to the Colonies. There is, in addition to the main index, a shipping list of more than 400 ships known to have been engaged in transatlantic voyages between 1607 and 1685, with the names, where known, of owners, masters and mershants, dates and destinations and miscellaneous data.

Please note that all the information reported by Mr. Currer-Briggs was also reported by Mr. Francis Leeson of the Surname Archive, which report is following, although this duplicated information is only presented here from the Currer-Briggs report, as it is slightly more detailed. Mr. Leeson's source for this information was given as Genealogical Gleanings in England, by Henry F. Waters, 1907. Mr. Leeson notes that the "following mentions of the surname-sound occur in wills proved in the Prerogative Court of (the Archbishop of) Canterbury (known as 'PCC'), London, selected and abstracted by Henry F. Waters for the light they throw, either directly or indirectly, on New England families of the 17th century". Mr. Currer-Briggs also comments that "all of these references (except the last to Edward Upcher) are tied in with the families from Dedham, Essex, who migrated to Dedham and Ipswich, Massachusetts".

Among the early citizens of Boston, he was a man of note, mainly for his charitable disposition. Because he opposed the course pursued towards the Quakers, and did all he could to alleviate the distress of those of that persuasion who suffered persecution, he in turn became a martyr. His crowning offence was bribing the keeper of Boston jail to supply with food two Quaker women who were imprisoned, and would otherwise have starved to death. For this, he was fined 20 pounds (no inconsiderable amount two centuries ago) and banished from the colony. He went to Rhode Island and remained six years, until Governor Endicott had ceased to rule. Returning to Boston, he furnished a room in his house for the free use of the Quakers and many were the Friends who enjoyed his hospitality. He was possessed of quite a large property, his estate covering in 1637 the territory now bounded by Hanover and Richmond streets and the old water line, joining the terminus of the two thoroughfares. On this territory was his house, long known as the "Old Red Lyon" Inn. His name stands twenty-third on the list of the original members of the Ancient and Honorable Artillery Company. He was also a member of the church and, as might be expected, exerted considerable influence over the affairs of the infant town.
