

Christian Family Chronicles is a new periodical which is of great interest to many Upshaw family researchers. It is published bi-annually, the first issue was January, 1979, and is available from the Editor, Mrs. Agnes B. Pearlman, 2001 North Westwood Ave., Santa Ana, Calif. 92706, for \$6.00 per year; queries are free.

As many of you know, there are two early Christian family connections with the Upshaw family: Elizabeth, the wife of William Bradley and mother-in-law of Leroy Upshaw (RS), is thought to have been a Christian and research is now actively ongoing by several excellant genealogists to determine this. Also, Drury Christian, who died and left his will in 1783 Amherst Co., Va., had as his companion Elizabeth Upshaw, the widow of William Upshaw.

This is an excellant family periodical containing a wealth of early Christian family history and genealogy; I recommend it highly.

This issue of the UFJ contains some interesting Alabama material from Confederate service and pension files. Readers will notice that many of these soldiers and pensioners had their origins in Georgia, particularily western Georgia. Also printed in this issue is material from the "Alabama Biographical File" at the Alabama Department of Archives and History. This file is a collection of marriage and death notices, and other miscellaneous newspaper and magazine items which have been accumulated by the Alabama Archives. Although most of this information dates in the mid-1900s, I think you will find it both helpful as well as interesting.

Confederate Records

"Alphabetical Card File" of Alabama Confederate Soldiers

The following information has been taken from the "Alphabetical Card File" in the Alabama Department of Archives and History, Montgomery, Alabama, 36104, and reference to that file should be made when making inquirey to them.

These index cards were compiled mostly under the W.P.A. from records available to them at that time (1930s). Many State records, such as pensions, indigent family records, Governor's correspondence, original muster rolls and many miscellaneous sources such as printed histories, historical records, and etc. are included in this alphabetical card file.

It should be emphasized that, although this file does contain many names not to be found otherwise, it does not necessarily contain all the names of Confederate soldiers of Alabama found in the Compiled Military Service Records of Confederate Soldiers, as compiled by the United States War Department from captured, confiscated, and otherwise surviving Confederate records, such as muster rolls, returns, rosters, payrolls, appointment books, and hospital registers.

 - J. T. Upshaw states he is over 70 years old; he was born in Coweta County, Ga., 6 June 1841. Witnessed by Joe S. Bird.
- 2) Pension application dated 13 Jan 1923:

"Application of widow to be placed on pension roll after death of husband.."
Nannie(sic) Upshaw, widow of J. T. Upshaw, who died 19 Dec 1922 at
Columbiana, Shelby Co., Ala., married to him at Shelby Springs, Shelby
Co., Ala., on 30 Sep 1892 (1872?). "I was born at Shelby Springs, Shelby
Co., Ala., on 25 Feb 1852; my age is 69 years, 10 mos., 18 days. I have
always lived in Alabama". Children: "none".

3) Letter dated 21 Jan 1925:

From L. B. Riddle, Judge of Shelby County, to Alabama Pension Commission, Montgomery, Ala, requesting them to "transfer pension voucher of Mrs. Nannie Upshaw from Bibb County to Shelby County, as she has moved back from Bibb to Shelby County."

4) Application dated 31 Nov 1927:

"Application for admission into the J. M. F. Soldier's Home of Alabama."

Nancy Upshaw, widow of a Confederate veteran, age 75; resided for past
two years at Columbiana and Wilsonville, Ala; widow - no children; now on
pension roll for Shelby County; not married second time.

Admitted to home 16 Aug 1930.

Veteran's name: John A. Upshaw

Pensioner: Sallie F. Upshaw, Tallapoosa County, Ala. Military record: Private, Co "B", 1st Georgia Cavalry.

1) Application dated 17 Aug 1904:

Mrs. Sallie F. Upshaw, widow of John A. Upshaw, Private in Co. "B", 1st Georgia Cavalry; husband died on 14 Feb 1903.

Affidavit of witnesses signed by James J. Scogin and James W. Taylor,

both of Meriwether County, Georgia.

Schedule of personal property shows 3 acres of land in Tallapoosa Co., valued at \$350.00 and "one old buggy", valued at \$10.00.

Veteran's name: John R. Upshaw

Pensioner: Eliza F. Upshaw, Shelby Co., Ala.

Military record: Private in Co. "B", 1st Georgia Cavalry.

1) Application dated 22 Jul 1912:

Eliza F. Upshaw, widow of John R. Upshaw, Private in Co. "B", 1st Georgia Cavalry, who died on 6 Jun 1898. Sworn to by J. T. Upshaw and William Tinny, both of Shelby County, Alabama.

Schedule of property shows dower interest in 370 acres of land in

Coosa County, valued at \$1,000.

2) Reclassification certificate of age of widow of Confederate soldier, dated 16 Apr 1915, taken in Fulton County, Georgia:

Eliza F. Upshaw, resident of Shelby Co., Ala., states that she was born near Newnan, Ga., in Coweta Co., Ga., on 24 Apr 1832, now 83 years old.

3) Application for widow's reclassification, dated 11 Jan 1916:

Eliza F. Upshaw presently drawing pension in Shelby Co; husband's name was John R. Upshaw; my age is 83 years, 8 months, 11 days; exact date of our marriage is 31 Aug 1851. Sworn to by J. T. Upshaw.

Veteran's name: John R. Upshaw

Pensioner: Julia C. Upshaw, Calhoun Co., Ala. Military record: Private, Co. "F", 7th Georgia.

1) Application for pension, dated 26 Jun 1901:

John R. Upshaw of Calhoun County, enlisted as a Private in Co. "F" in the 7th Georgia Regiment on the 28 Apr 1861 in Atlanta, Georgia; honorably discharged on 10 Apr 1865; presently 60 years of age, suffering from lung trouble. Sworn to by F. M. Patty, H. S. Jones, and A. H. Dukes, both of Cherokee County.

2) Application for reinstatement of Confederate soldier to the pension roll, dated 24 Jan 1916:

This states that John R. Upshaw of Calhoun County was striken from the pension roll 1 Jan 1913, the charge made against him being "the records of P. O. W. (Union) show that John R. Upshaw deserted at Richmond, Virginia, 7 Mar 1865, and was sent North".

Affadavits sworn to by A. H. Duke and J. F. Parker of Calhoun County. (These papers show that a \$16 per month pension was paid him from Jan 1913 to Jan 1916); pension reinstated 28 Jan 1916.

3) Affadavit of R. B. L. Jennings, dated 20 Nov 1913:

The State of Alabama, / Calhoun County / Before me, Jos. J. Arnold, a Judge of Probate in and for said County, personally appeared R. B. L. Jennings, who being duly sworn doth depose and say that he knows John R. Upshaw, and that affiant is the son of David Jennings, deceased, that affiant's father was a Confederate soldier, being a member of Gen. Jos. Wheeler's Cavalry, that after the war affiant has on several occasions heard his father (David Jennings) tell of said John R. Upshaw's being captured by the Federal troops while the said Upshaw was a Confederate soldier and serving as such; and that he (David Jennings) was present when said Upshaw was detailed to do scout duty and that he was captured while he was serving on such detail.

Sworn to and subscribed this the 20 day of Nov 1913. (signed) R. B. L. Jennings

(witnessed) Jos. J. Arnold, Judge of Probate

4) Affadavit of John R. Upshaw, dated 20 Nov 1913:

The State of Alabama, / Calhoun County / Before me, Jos. J. Arnold, as Judge of Probate in and for said County, personally appeared John R. Upshaw, who being by me first duly sworn doth depose and say that he enlisted in Company "F" of the 7th Georgia Regiment of Confederate Army (Infantry) in May of 1861, in Carrollton, Georgia, and served in said Company down to the end of the war; that he never deserted said army; that in March of 1865 he was detailed with a small party of Confederate soldiers to do scout duty, and that while engaged in this service, affiant with his comrades was captured by the Federal troops in Tennessee, and was taken by the enemy to a Federal prison, and that he was kept in prison as a prisoner of war until the end of the war, when he was liberated, and that he then returned to his home at Carrollton, Georgia. Sworn to and subscribed this the 20 day of Nov 1913.

- 5) Application of soldier over 70 years of age to be advanced from 3rd to 2nd class pension, dated 12 Apr 1919:
 - J. R. Upshaw, born at Carroll County, Georgia, on 10 Dec 1841. Sworn to by J. M. Lusk, "known him for 25 years".
- 6) Application of widow to be placed on pension roll after death of husband, dated 17 Jan 1921:

Julia C. Upshaw, widow of J. R. Upshaw, who died 1 Nov 1920 at his residence in Calhoun County, Alabama; married to him at my father's residence in Calhoun County, Alabama, on 18 Dec 1890. I was born at Calhoun County on 3 Sep 1860; I am now living with my son, Kirk, at Jacksonville, Rt. no. 1, Calhoun County, Alabama.

Confederate Military Service Abstracts

Adkin Upshaw; Co "E", 4 Regt. (Russell's) Alabama Cavalry, CSA:

1) A. Upshaw, Private, Capt. Graham's Company, Russell's Battalion of Partisan Rangers (this Company subsequently became Company E. 4th Regiment (Russell's) Alabama Cavalry), age 30 years, appears on Company muster-in roll of the organization named above. Roll dated, camp near Taylor's Store, Tennessee, 22 Sep 1862. Muster-in date, 22 Sep 1862.

(Editor's note: Although I do not find the location of "Taylor's Store, Tennessee" on any present-day map. I do find the following listing in War of the Rebellion, Official Records of the Union and Confederate Armies, serial no. 130, General Index:

"Taylor's Store, Alabama" is referenced as being shown in the Atlas portion of this compilation)

He enlisted September 8, 1862 at Stevenson (Jackson County), Alabama; enlisted by Capt. F. J. Graham for "3 years or during the war".

He is shown as having valuation of \$165.00 of horses and of \$10.00 of horse equipments.

2) Adkin Upshaw, Private, Company "E", 4 Reg't Alabama Cavalry, appears on a Campany muster roll of the organization named above, for Oct. 31 to Dec. 31, 1863.

He enlisted Sept. 8, 1862, at Stevenson, Alabama; enlisted by Capt. Graham for the period of the war.

He was last paid by Capt. Gibbons to the time of April 30, 1863. At the time of this muster roll he is "absent without leave".

Joseph H. Upshaw; Co "B", Moses' Squadron, Alabama Cavalry, CSA:

1) Joseph Upshur(sic), Capt. Wm. T. Smith's Cav. Co. (see editor's note, below), appears on a list of members of the organization named above, who voted at an election held for Company officers the 30 March 1864; list dated at Headquarters cavalry camp near Demopolis, Ala., March 30, 1864.

(Editor's note: This Company subsequently became Company "B", Captain Moses' Squadron, Alabama Cavalry. This squadron was transferred to the 8th Regiment Alabama Cavalry by S. O. no. 147, dated Headquarters Selma, October 6, 1864, and became Companies I & K of that Regiment).

2) J. H. Upshaw, Private, Co. "B", Capt. S. A. Moses' Squadron, Cavalry (see Editor's note on item above), appears on a Company muster roll of the organization named above, for Sept. 1 to 30, 1864.

He enlisted Sept. 22, 186, at Wedowee (Randolph Co.); enlisted by Major Hunt "for war".

At the time of this muster roll he is "present".

"Name appears in column of names present as Joseph H. Upshaw".

page 266: John H. Upshaw biographical sketch:

John H. Upshaw was born in Meriwether County, Ga., in 1840, and died Feb. 11, 1903. He was the eldest son of Middleton Upshaw, whose ancestors, French, date back to the early settlement of the United States. He was educated in the common schools of Georgia, entered the Confederate service and remained in it all through the war. He married after the close of the war and settled in Tallapoosa County, Ala. He devoted his time to farming. He had a family of four children, two boys and two girls. The former are John, a leading businessman of Dallas, Texas, and Thomas, of Sherman, Texas. His two daughters are both married: Mrs. S. Parkhome, of Columbus, Ga., and Mrs. A. D. Turner, of Jackson Gap, Ala. His widow survives him.

A collection of marriage and death notices, other newspaper and magazine items, letters of inquirey, and other miscellaneous material concerning persons named Upshaw which has been accumulated by the Alabama Dept. of Archives and History, Montgomery, Ala; located in filing cabinets on the floor of the main research room. (Editor's note: I have edited the material in this file to reflect only that which has genealogical value and which does not originate in other primary sources, such as census records, etc.)

Adrienne Lee Upshaw; Montgomery Advertiser, 7 Feb 1942:

Adrienne Lee Upshaw, 4-year-old daughter of Mr. and Mrs. Ralph B. Upshaw, 9 Findley Curve, died at a local hospital early Friday following an illness of three days. Surviving are the parents, grandparents, Mr. and Mrs. J. B. Connell, Montgomery, and Mrs. Hattie Upshaw, Breman, Ga. The funeral was held from White Chapel Saturday at 10 a.m., with Dr. Gaston Foote, pastor of the First Methodist Church, officiating. Burial was in Greenwood Cemetery.

Adrienne Lee Upshaw; Montgomery Advertiser, 7 Feb 1942:

The funeral for Adrienne Lee Upshaw, infant, was held from White Chapel Saturday at 10 a.m. with Dr. Gaston Foote officiating. Burial was in Greenwood Cemetery. Pallbearers were Charles Davis, J. B. Sneed, Ed Pepperman and Dana Fillingin.

Mrs. Ammie Davie Upshaw; Montgomery Advertiser, 24 Aug 1937:

Hurtsboro, Ala., Aug. 23 - Mrs. Ammie Davie Upshaw, 56, died at her home yesterday after an illness of several weeks. She was a member of one of the oldest families of Russell County. She leaves her husband, Lee J. Upshaw; two sons, Leroy D. Upshaw, and Judson D. Upshaw, of Hurtsboro; also her mother, Mrs. Lula Davie and one brother, Rutledge Davie, of Spring Hill. The funeral was held this afternoon from her home with burial in the family plot at Spring Hill.

Aubrey R. Upshaw, Jr.; Birmingham News, 10 Nov 1944:

Lt. Aubrey R. Upshaw, Jr., Homewood, now with a veteran troop carrier squadron of the Mediterranean Allied Air Forces, has been awarded the Air Medal. Lt. Upshaw was co-pilot on one of the big troop carrier planes that towed gliders across the Riviera coast on the afternoon of D-Day in Southern France.

Aubrey Russell Upshaw, Jr.; Montgomery Advertiser, 20 Feb 1944:

Miss Torbert and Cadet Upshaw to be wed.

The engagement of Miss Evelyn Adams Torbert, daughter of Mr. and Mrs. James Everett Torbert, of Demopolis, to Aviation Cadet Aubrey Russell Upshaw, Jr., son of Mr. and Mrs. A. R. Upshaw, of Birmingham, announced this morning, is of interest. The marriage will take place in March and will be a ceremony at the First Presbyterian Church in Demopolis.

Miss Torbert received her preparatory education in Demopolis and attended Alabama Polytechnic Institute where she was a member of Kappa Delta Sorority. She was featured in the beauty section of the Glomerata. She is a sister of Mrs. W. B. Wood of Montgomery, and is a favorite in this city where she often visits.

Cadet Upshaw graduated from Phillips High School in Birmingham. He attended Alabama Polytechnic Institute where he was a student when he began his training in the U.S. Army Air Forces, and was affiliated with Alpha Tau Omega fraternity. At present he is stationed at Turner Field, Albany, Ga., where he will receive his commission in March.

Aubrey Russell Upshaw, Jr.; Birmingham News, 20 Feb 1944:

Aubrey Upshaw, Jr., engaged to marry Evelyn Torbert.

Aviation Cadet Aubrey Russell Upshaw, Jr., stationed at Turner Field, Albany, Ga., son of Mr. and Mrs. A. R. Upshaw of this city, is engaged to wed Miss Evelyn Adams Torbert, Demopolis. The announcement is made by Miss Torbert's parents, Mr. and Mrs. J. E. Torbert.

Particulars as to the illness of Mr. Upshaw are meager and it is only known that he was stricken on the streets of Gadsden where he was on business at the time, and taken to the Rawls infirmary where he died this morning. Surviving are his wife, who resides on Franklin Street, three children, Ann, Jimmy, and Martha; two brothers, James C. Upshaw, of Covington, Ga., and Will Upshaw of Raleigh, N. C., and four sisters residing in Covington, Athens, and Monroe, Ga., respectively.

Mr. Upshaw will be missed by many of the farmers of this county, whom he aided by practical and constructive methods of agriculture and also by members of the boys 4-H clubs, whom he also assisted in their work.

H. L. Upshaw (pictured) of Eufaula has done a good job with his cotton this year and the crop is practically made. Right now, he's busy keeping out boll weevils. Later on, the crop will be defoliated, picked and hauled to the gin. The farmer expects to get a bale from eack of his 48 acres.

This is a story about a farmer-newsman who seldom sees his name in the papers. It's not because he hasn't been doing a bang-up job of farming for years. He's been making money with cotton, peanuts, grain and livestock.

This man is H. L. Upshaw, a top-notch farmer and prominent civic leader who is editor and publisher of the Eufaula Tribune, a semi-weekly paper.

When he isn't writing or assembling it, Upshaw is making news ... out on his 1200-acre farm near Eufaula, says Barbour County agent, Jess Walton.

Upshaw and his farm manager, Jim Rutland, earn a big slice of their farm income through king cotton. This year they have a little more than 48 acres planted and are expecting to pick at least 48 bales. The fiber crop has received good treatment. First, it was planted in a well-prepared seedbed. Each acre was fertilized with 500 pounds of 0-12-12 and side-dressed twice with a total of 350 pounds of soda.

Upshaw admits the bale per-acre crop is made. And he's one of these upto-the-minute farmers who doesn't believe in letting the bugs eat up his crop. For this reason, he's following a strict poisoning schedule, using planes. The farmer likes to use the plane better than the tractor because it's faster and there's less injury to plants.

Upshaw will also harvest his share of the bumper corn crop in Alabama this year. The grain farmer has fertilized each of his 150 acres with 400 pounds of 4-10-7 and 175 pounds of ammonium nitrate. He and Walton agree the yield should be at least 50 bushels per acre or a total of 7,500 bushels.

Upshaw, realizing corn brings the top dollar when sold through livestock, plans to creep feed part of the grain to beef calves, more will go into feeder pigs, and the rest will be sold.

The other major row crop on the place is peanuts. There are 32 acres which have been dosed with 400 pounds of 4-10-7 per acre and three 20-pound per acre applications of sulphur. Like most of the peanut fields in southeast Alabama, Upshaw's looked mighty skippy at the first of the season. Nevertheless, the farmer says he'll harvest around 25 tons. The hay will be baled for the beef herd.

Upshaw's 85 grade Hereford brood cows round out the farming program. They graze 800 acres around the clock. Half of the pasture acres have been improved and the rest are covered with native clovers and grasses.
