

TENNESSEE

1910 Census (Soundex Index). The Soundex filing system keeps together names of the same and similar sounds but of variant spellings. This card index was created by the Bureau of the Census for only 21 states in the 1910 census, and is supposed to include every name in the 1910 Census schedules. The Soundex Index contains the following information on cards: surname, first name, state and county of residence, city (if appropriate), race, age, and place of birth. (Note: Most of the cards for 1910 Tennessee showed no place of birth, only occasionally given for states other than Tennessee, and one might assume the place of birth is Tennessee where no state is given.)

The 1910 Index for Tennessee cities is separate from the rest of Tennessee, but the Upshaw references have been combined here into one alphabetical list for easier research use.


