THE EDITORS DESK



Greetings for 1977! 1976 was a very busy year for me, having been a major contributor of Virginia Arnold records for publication by the Arnold Family Association of the South, maintaining the publishing schedule of the Upshaw Family Journal, and having published my first major reference book, Georgia Wills, 1733-1860, which is an index to testators of every will recorded in Georgia from 1733 through 1860. I am especially thankful for the help and encouragement of my wife Pam and we are extremely gratified by the response of the genealogical and historical field to the book. I anticipate a more leisurely pace in 1977 and hope to move publishing of the Journal ahead by several months, which I have not yet been able to accomplish.

In the fall of 1976 I abstracted the Upshaw references from more than 300 volumes of Tennessee county records, which were transcribed and indexed by the W. P. A. during the 1930s, located in the University of Tennessee Library, Knoxville, Tennessee. I concentrated on Giles, Monroe, Montgomery, Roane, and Shelby counties, although several important items were found in some other counties.

I also arranged the papers of Mrs. Charlotte Parrott, Alexandria, Louisiana, into family groups and copied that information onto family group forms and added those to our file. Mrs. Alice Smith, Shreveport, Louisiana, was able to secure copies of all (male) Upshaw family group record sheets in the Genealogical Library of the Mormon Church in Salt Lake City, Utah, which have also been added to our family group record sheet file. I also copied all Upshaw entries from the CFI index, which contains references to over 28,000,000 names, at the IDS Branch Library in Dunwoody, Georgia, which are a valuable addition to our records. Several members have also contributed Upshaw source records and family group sheets, so we are progressing.

The thorough coverage of Amherst County, Virginia, records presented in this issue will be of great interest to all Upshaw family researchers, who should also refer to UFJ Vol I (# 3), pages 78-85 for abstracts from Amherst County, Virginia, in the Revolution, by Lenora H. Sweeny. The extensive coverage of the allied families of Christian and Moorman in this issue provides informative new insight into those family connections.

The marriage bond of John Upshaw and Amey Gatewood, printed on the "Upshaw Family Album" page in this issue, will be interesting to everyone. A copy of the original marriage bond of Leroy Upshaw and Elizabeth Bradley will be presented in the Spring issue, with the 1820, 1830, and 1850 Virginia census indices, and all county records of Virginia with the exception of Essex County.

UPSHAW William UPSHAW (son of Cordelia Martin) and his wife Hannah,
whose daughter Susanna UPSHAW married William BROOKING before
December 1716. The will of William UPSHAW, dated 16 Dec 1716,
recorded 17 May 1720 in Essex Co., names daughter Susanna BROOKING.

The following deed is found in Essex County, Virginia: 10-11 Apr 1719; William BROOKING and Susanna his wife, of Petsoe Parish, Gloucester County, Virginia, to James Reynolds, part of 920 acres on branches of Cockshall Creek, granted to Leonard Tarrant by patent 28 May 1716, which said part contains 230 acres as by two div., one Dec. 1715 and one June 1716. Recorded 19 May 1719. Ackl. by William BROOKING and Susanna his wife who was privately examined by Lawrence Taliaferro.

AMHERST COUNTY

Deeds, 1761 - 1843

Amherst County deeds, Books A through N, have been abstracted and printed by Mr. Bailey F. Davis; all Upshaw references in these books are included in the index and abstracts below. Mr. Davis comments that "it is queer to relate, but not a single person with last name beginning with U is to be found in the will books here (Amherst County) from 1761 to 1919 master index. However, there are many deeds for that period." Of course, we know that John and Leroy Upshaw had removed from Amherst County, Virginia, to Elbert County, Georgia, by 1790 and that John Upshaw's will is recorded there in 1834.

Grantee - Lee Roy Upshaw. Residence - "of the said county". (note: although there is no specific county named, the only county actually previously written in the deed is Bedford)

Amount paid - 100 pounds. Acres - 400 acres.

Description - in Amherst County on the north side of the Fluvannah River on Stovall's Creek, (same legal description as in deed book E, page 166-168), "together with all houses, orchards, gardens, roadways, roads, water and water courses, woods and underwoods, advantages, priviledges, and all other appertenances thereto belonging or in any way appurtaining and the reversion and reversions, remainder and remainders thereof and every part and parcel thereof to the said Lee Roy Upshaw and to his heirs and assigns forever."

.... "he the said George Stovall at the time of the ensealing and delivery of these present is and stands seized of an indefeasable estate of inheritance in fee simple in the said lands and premises"

Description - On the north branches of Buffaloe River, beginning at pointers in Stanhope Evans line, thence a new line north 28 degrees west 156 poles to a white oak saplin(sic) in Stanhope Evans's line and with them north 62 degrees east 194 poles crossing a branch to a red oak and south 50 degrees east 98 poles crossing a branch to pointers in James Freeland dec'd line and with it south 22 degrees west 6 poles to pointers corner to Thomas Evans and with his lines south 46 degrees west 122 poles to pointers and south 21 degrees east 104 poles to pointers corner to Stanhope Evans and with his lines south 70 degrees west 106 poles to pointers and south 50 degrees west 25 poles to the first station and is part of a larger tract belonging to Stanhope Evans.

Grantor - Leroy Upshaw. Residence - Amherst County Grantee - Joseph Crews. Residence - Amherst County

Amount paid - 2000 pounds. Acres - 400 acres.

Description - In Amherst County on the north side of the Fluvanna River on Stovall's Creek; "Beginning at a white oak and running thence south 11 degrees east 22 poles, crossing the creek to pointers, south 85 degrees east 180 poles to pointers, north 37 degrees west 30 poles to pointers, south 53 degrees west 46 poles to a white oak, south 37 degrees west 72 poles to a pine, north 83 degrees west 40 poles to pointers, south 40 degrees west 36 poles to a white oak, north 67 degrees west 126 poles to pointers, south 61 degrees west 20 poles to a red oak, north 48 degrees west 44 poles to a possimon(sic), north 25 degrees east 275 poles to a pine, south 64 degrees east 350 poles to pointers, and south 52 poles to the beginning, together with all houses, orchards, gardens, fences, waters and water courses, ways, roads, woods and underwoods, profits, advantages, commodities, and all other appurtenances whatsoever to the same belonging or in any wise appertaining."

(Editor's note: Leroy Upshaw purchased this property for 100 pounds in 1773 and sold it for 2000 pounds in 1779! The only difference in the legal descriptions in the deeds is in this deed when the land is sold, where mention is made of "profits and commodities", which must relate to the tremendous increase in the value of the property. The title to this property can be followed through Joseph Crews, which might reveal specifically what "profits and commodities" these are.

When Leroy arrived circa 1790 in Elbert County, Georgia, from Buckingham County, Virginia, there is nothing to indicate that his estate amounted to 2000 pounds, which was a rather large sum in those days. What transactions caused this mystery?)

The land purchased of Evans, 200 acres and bounded as follows, to wit - being part of a larger tract, beginning at pointers in Stanhope Evans' line, thence a new line north 28 degrees west 156 poles to a white oak saplin(sic) in Stanhope Evans' line, and with them north 62 degrees east 194 crossing a branch to a red oak and south 50 degrees east 98

Whereas an action of Ejectment depending in the county to wit of Amherst between Elizabeth Upshaw pltff against Elizabeth Christian, widow of John Christian and administratrix of his estate.

The parties have agreed to compromise the said suit. The said Elizabeth Upshaw doth agree to relinquish and release all her claim, right and title to the lands in the declaration mentioned to the said Elizabeth Christian and the heirs of John Christian deceased in consideration of which said release to as aforesaid made by the said Elizabeth Upshaw to the said Elizabeth Christian and the heirs of John Christian deceased. The said Elizabeth Christian on her part doth hereby covenant and agree to and with the said Elizabeth Upshaw to pay to her the said Elizabeth Upshaw for the two years use and occupation of the plantation heretofore had and enjoyed by the said Elizabeth Christian, that is to say from the 1st day January 1811 to the first day of January 1813 the sum of 80 dollars per amum, making the sum of 160 dollars for the time heretofore elapsed and passed.

And further the said Elizabeth Christian doth covenant and agree and thereto binds herself, her heirs and executors, to pay yearly and every year, that is to say, the first day of January in each year during the life of the said Elizabeth Upshaw, the annual sum of 80 dollars. The first payment of which said annuity to be made on the first day of January in the year of our Lord 1814 and so on on the first day of January in every year for so long a time as the said Elizabeth Upshaw shall live and if the said Elizabeth Upshaw shall die between the first day of January and the last day of December, then the annuity for that year to (be) aportioned and payment made for such part of the year as she shall live.

In witness whereof the parties hereto hath hereto set their hands and seals this 15th day of March 1813. That is to say Elizabeth Christian for herself and Henry Moorman as Attorney in fact for Elizabeth Upshaw.

It is agreed and understood by the parties, that is to say, between Elizabeth Upshaw and Elizabeth Christian that she, the said Elizabeth Upshaw hath no further or other claim against the administratrix of John Christian deceased, the within granted annuity excepted and she doth

excepted and she doth release all claim or claims and agrees that all settlements, agreements & c heretofore made by herself and Pleasant Dawson or either of them with the administratrix of John Christian deceased shall stand good against any claim that may be made by her or her representative against the administratrix. Witness the parties have hereto put their seals the day and date within written.

Know all men by these presents that I, Elizabeth Upshaw of Amherst County, have made, ordained, constituted, and appointed and by these presents do make, ordain, constitute, and appoint Henry Moorman of Campbell County my true and lawful attorney to ask, demand, sue for, recover, and receive all rents and arrears of rents due me from Elizabeth Christian as Tennant or occupier of my lands and tenements lying in Amherst County on James River and upon payment of said rents to give acquittance and discharge for the same as if I were personally present hereby confirming whatsoever my said attorney shall lawfully do or cause to be done in or about the premises.

At a court held for Amherst County the 15th day of March 1813 this agreement was proven by the oathes of Pleasant Dawson and Jas. Dillard and ordered to be recorded.

If one will consult my C wills, it will be seen that Drury Christian left a will wherein he speaks of 'my beloved companion, Elizabeth Upshaw' and all of his children bear names of Upshaw rather than Christian. John Christian was his brother and Drury names him in his will, too. One Drury Christian married here fairly early, but his father, Robert Christian, gave consent."

5W(1)262: Christian Family genealogy (readers may wish to refer to the William and Mary College Quarterly, volume 5, for the complete article)

Owing to the destruction of the New Kent county records, and the partial destruction of the Charles City county records, it is difficult to connect this family with any of the English families of the same name in the Isle of Man and other places. Investigations in British wills and other records on the other side of the ocean may some day supply the loss.

We know that the Virginia progenitor of the family was 1, Thomas Christian. As "Mr. Thomas Christian" he patented, Oct. 21, 1687, 1080 acres in Charles City County. While the family did not assume in the eighteenth century the important position it has enjoyed in the nineteenth; the term "Mr.", accorded to the immigrant, is indicative of social standing. In 1694 "Thomas Christian, Sen." got a patent for 193 acres south of Chickahominy Swamp. The "Sen."

here shows that there was another Thomas Christian, who was probably a son of the elder Thomas and already of age. Then we find 2, Thomas² Christian, of "Charles City county," patenting land (1712 and 1727) in the forks of Beaver Dam Creek in that part of Henrico called Goochland; 3, Charles² Christian, of "Charles City," locating lands in same vicinity (1714, 1727); 4, James² Christian in same vicinity, bounding on Thomas Christian's line (1719); 5, John² Christian, of "Charles City," in same vicinity (1724).

All this furnishes strong presumptive evidence in the absence of any other Christians mentioned in the records of Charles City and New Kent, that 2, 3, 4 and 5 were sons of 1, Thomas Christian,

Sen., the immigrant.

2, Thomas² Christian's will was proved in Goochland county in 1736. He married Rebecca (perhaps the daughter of Drury Stith, near whom, in Charles City, Thomas Christian patented 1320 acres on Dec. 16, 1714), and had issue: 6, Thomas³; 7, Robert³; 8, William³ of Albemarle county, living in 1756; 9, James³; 10, Constant³; 11, Rebecca³; 12, Ann³; 13, Mourning³, who married Coleman. Mentions grandson Thomas.

7, Robert³ (Thomas², Thomas¹) lived in Albemarle county, which was cut out of Goochland. His will, proved at May court, 1749, mentions wife Incy, sister of William Bradley, and issue: 24, John⁴; 25, Robert⁴; 26, Drury⁴; 27, Incy⁴; 28, Elizabeth⁴. Witnesses to will: Walter Leak, Charles Christian, William Christian. Wife probably with child.

26, Drury Christian, of Goochland county, married Lucy Williams, and had issue: 29, James 5, born April 30, 1758; 30, Gideon 5, born Aug. 16, 1760; 31, Ann 5, born March 3, 1764; 32, Drury 5, born Aug. 18, 1766. (Register of Births, etc., kept by Rev. Wm. Douglas.)

Christian family notes (compiled by Mrs. Frank N. Reeder, who gives no documentation for the following)

Lucy Christian, wife of Robert Christian (died 1749), was the sister of William Bradley, who was married three times in Charles City County, Virginia. (Editor's note: If Robert Christian was the son of Thomas Christian, who died in Goochland County, Virginia, in 1736, Robert was probably born in Charles City County, where his father lived, which may be a clue to the early origins of William Bradley, whose daughter, Elizabeth Bradley, married Leroy Upshaw).

Drury Christian, named as a son in the will of Robert Christian, married Mourning Christian, daughter of Charles Christian, who died in 1784, Goochland County, Virginia. (Editor's note: If the Drury Christian who married Lucy Williams in 1751, Goochland County, was the son of Robert Christian (died 1749), then this Drury's son, Drury, who was born in 1766, Goochland County, may have been the one who married Mourning Christian, daughter of Charles Christian).

John Christian, deceased, leaving Elizabeth Christian his widow, and children, infants; wife of Henry Moorman (daughter of Drury); wife of Pleasant Dawson (daughter of Drury); answer of Dawson sworn to in Amherst County.

Will of Daniel Hix: names wife, Joan; daughters Lucy and Winifred, etc. Dated 26 Nov 1734, recorded 15 Jul 1735 in Goochland County, Va. (Editor's note: I do not know the date of this Amherst County court item, although I estimate it to be circa 1810; the will of Daniel Hix is unimportant to this matter).

Editor's comments:

From the above item naming heirs of Drury Christian, and from other Amherst County documents presented in this issue, we find that the children of Drury Christian and Elizabeth Upshaw were:

- (1) Elizabeth <u>Upshaw</u>, who married Henry Moorman in 1788, Amherst County, Virginia; consent was given by her mother, Elizabeth Upshaw, as her father, Drury Christian, had died in 1783. (See Moorman family notes)
- (2) Sally Christian, who married Pleasant Dawson in 1791, Amherst County, Virginia; surety was by John Dillard who was guardian of the

orphans of Drury Christian. (Note: 1820 census indices show no Pleasant Dawson in either Virginia or Georgia)

(3) Lucy Christian Upshaw, may have been dead by the time of the above court case (circa 1810?), as she was not stated as an heir of Drury Christian, although she was named in Drury's will in 1783. I find no marriage record in Amherst County of this Lucy Christian Upshaw.

(4) John Christian, married Elizabeth (maiden name unknown).
John Christian died circa 1813 in Amherst County and his widow Elizabeth married John Dillard in 1816, who had been guardian to the orphans of Drury Christian. I believe this John Dillard was the son of James Dillard who married Mary Ann Hunt, step daughter of Forrest Upshaw and half sister to John, Leroy, and Mildred Upshaw. (See Dillard family notes)

John Christian's wife, Elizabeth, was not Elizabeth Upshaw - see Amherst County Deed Book M, page 322. In addition, John Christian's widow, Elizabeth, married John Dillard in Amherst County, 1816, and had children by him; the 1850 Amherst County census shows she was born in 1781, which is much too late to have been Elizabeth Upshaw, widowed by William Upshaw circa 1760.

One very interesting and crucial aspect of the records of these four children is the fact that all except Elizabeth did not use the name Upshaw, but Christian.

The most important information derived from these records is that there is no Drury Christian of the correct age to have been the Drury (Christian?) Upshaw of 1810 Pendleton District, South Carolina, and who died in Missouri! Forrester Upshaw (son of Leroy Upshaw, RS) has been located in Pendleton District, South Carolina, in 1805/6 and I believe herein is the relationship.

- I. Drury Christian, of the parish of Lexington and County of Amherst, do make and ordain this to be my last will and testament, revoking all other wills made by me, as to what it has pleased God temporally to bestow and give me. My will is to give and bestow in manner following, viz:
- I give unto my well beloved companion, Elizabeth Upshaw, one certain Bay mare called Janey.
- I lend unto my said well beloved, Elizabeth Upshaw during her natural life, all my estate of every kind, that is to say, my plantation and all the lands thereto belonging, and all other lands to me belonging, with all privileges and advantages on the said lands, also in like manner to said, Elizabeth Upshaw, all my utensils of husbandry, household furniture, stocks of horses of which I have given; also all my stocks of

cattle, sheep and hogs, except the above said mare; also one copper still and half of another copper still that I own in part with my brother, John Christian, and all other my estate, rights and privileges whatsoever, (except as heretofore excepted).

I give and bequeath to my son, John Christian Upshaw, all my land that I now am possessed with, after the death of his mother, Elizabeth Upshaw (except as hereafter excepted).

I give unto my four children, viz: John Christian Upshaw, Elizabeth Christian Upshaw, Lucy Christian Upshaw, and Sally Christian Upshaw, to be equally divided between them, or such of them that are living agreeable to the following terms, (to-wit) the following slaves: Dublin, Phebe, Alice, Orson, Ratler, and Ralph and their increase, and that it may be clearly understood that said slaves are to remain on the above said lands for the maintainance and subsistance of the above said Elizabeth Upshaw and said children until either of them come of age or marry, then the said slaves to be equally divided amongst such of them that are living, and that one of them coming of age or marrying to receive his or her part; and the remaining slaves to continue on said land or plantation under the conduct of the said Elizabeth Upshaw until the next child comes of age or marries, then in like manner to be equally divided, and the one then coming of age or marrying then to receive his or her part, and in like manner so to be continued, until all my children come of age or marry, at which time they are to receive their proportionable part, and if any of my said children should die before coming of age or marrying in proportion the residue of such of them as may die is to be equally divided between such of them that are living, as well as the one coming of age or marrying as those that are not come of age or married, so as to make their parts as equal as possible and of my son, John Christian Upshaw, should die before he comes of age or marries, then all my lands which I have given to him after the death of his said mother, be equally divided between my other said children that are then living (except as hereafter excepted).

I give to my brother John Christian, a half the privilege of my fishery, and a small piece of land, the quanity unknown, chopt(sic) from the lower end of my lands and adjoining his lands, to him, his heirs and assigns forever.

I further give to each of my aforesaid children, as they come of age or marry and it the same terms to be received out of the estate lent to my beloved companion Elizabeth Upshaw, one good feather bed and furniture, one good horse bridle and saddle and five head of cattle, and after the decease of the said Elizabeth Upshaw I give all the estate that then remains as lent, in the hands of the said Elizabeth Upshaw, except such as I have given specifically given to be equally divided between my aforesaid children and in the case any of them to be then dead, to be divided between such as are then living, or legally represent them.

I do hereby appoint the aforesaid Elizabeth Upshaw my executrix to act and do according to the purpose of this my last will and testament, bearing date this 10th day of March 1783.

I do hereby sign, seal and pronounce this writing to contain my last will and testament in the presence of

Personal estate and Lynchburg property to be sold and all debts paid. To wife Elizabeth during her natural life the following slaves: James and his wife Phillis and their children, Jane and Austin; Mary the daughter of Dinah. Also personal property. "My wife shall have full possession of the mansion house and the part of land allotted to my son Drury C. Moorman during her lifetime." To daughter Lucy C. Dillard \$250.00 in addition to property given her hereafter. "In addition to the property given by me to my daughter Betsy in her lifetime, I now give and bequeath to her children Lucy C. Clarke, Mildred Ann Pursell, Henrietta, Maria, and Tomasia(?) Purcell \$1000 to be equally divided". To son Henry T. Moorman the balance due me upon his bond in my possession.

In addition to personal property given son John J. Moorman and now in his possession, the tract of land on which he now lives, 551 acres.

In addition to personal property and lot of ground in town of Lynchburg, to daughter Mary H. Dillard, \$1000.

To son Drury C. Moorman, 1/2 of tract of land whereon I now live being the east part of land lying on Ward's Road. Also a negro man named Stephen; a negro boy George; also personal property.

To son Zachariah Moorman the balance of my tract of land whereon he now lives, being the west part of my tract, and lying on Otter River.

In addition to Robert, a negro boy Peter.

In addition to the two negro boys, Nathan and Caleb, given heretofore to daughter Sarah Ann Jones, given to my two infant grandchildren, children of my daughter Sarah Ann Jones, Henry Bowling Jones and Sarah Catharine Elizabeth Christian Jones, \$1000 to be equally divided.

To wife Elizabeth, the following servants for support of her family during her lifetime: Lery(sic), Dinah, Abner, Archer, Henry, and Ralph; also personal property.

"Son Drury shall take charge of my wife and the negroes loaned to her with the mansion house and farm allotted to him together with so much of the household and kitchen furniture as shall be requisite for her support."

Codicil written 1 Jul 1834 authorizing executors to sell and convey all property, both real and personal, ". Witnessed by Thomas Moorman, Jeffrey Murrell, David B. Lamb.

Executors: "My 4 sons", Henry T. Moorman, John J. Moorman, Drury C. Moorman, and Zachariah Moorman.
